**Rules** -Tournament Director Jim Malicott will interpret the following rules and ALL decisions will be final!

**This is a team tournament (2 people) and you must have the same partner all day.** Boat numbers will be assigned by the order in which they are received and will be given out on Saturday evening November 10, 2012 at 6:00pm under the pavilion. Rules will be distributed and discussed. Entry fee is nonrefundable after October 31, 2012 Participants are encouraged to attend this meeting. If arriving Sunday morning, participants must check with Tournament Director upon dispatching their boat. Tournament Director will be at Eufaula Cove Ramp from **5:00 to 7:30 am.**

**Departure & Return-** the total number of entries will determine the number of flights. A team may launch the morning of the tournament from any ramp on the lake and begin fishing at their designated start time. Start times and weigh-in times will be staggered accordingly to give each team an equal amount of time to fish. Each team will be on the honor system for their start time and livewell check. You will be subject to a polygraph test. **You must have your boat on a trailer the night before tournament and you may not unload until 5:00am. Then you may proceed to your fishing hole, but may not start fishing until their flight time starts.** First on a fishing hole has right to hole if they have their anchor down and trolling motor out of water.

**One member of each team must check in at weigh-in site by their designated time in order to be on time.** Teams must return to pavilion to weigh fish. We reserve the right to assign flights and hours deemed necessary.

**Permitted Fishing Locations-**Teams may fish anywhere on tournament water accessible by boat from Eufaula Cove, except areas designated as "off limits". **Eufaula Cove is OFF LIMITS!**

You cannot fish within 50 yards of another contestant with their anchor down and trolling motor out of the water.

**Scoring- Three (3) fish limit. 14" minimum.** Bass measurement-mouth closed anyway to tail to mark. Only large mouth, spotted and small-mouth bass will be counted. No dead fish will be weighed. If fish is less than 14" there is a penalty of one (1) pound per fish. If more than three (3) fish are brought to weigh-in, the smallest three (3) will be weighed. In case of a tie, the winner will be the team with

the biggest fish. If a tie still exists, the winner will be determined by the flip of a coin. Fish will be measured on a Golden Rule flat board. **Participants must use weigh-in bags furnished by Tournament Director, if not automatic disqualification will result.**

**Tackle & Equipment-**Only artificial bait or lures may be used. Pork style baits are allowed. All bass must be caught on a rod and reel. We support the "catch and release" program and encourage all participants to release your fish after weigh-in.

**Automatic Disqualification-**One (1) pound per minute deducted for late arrival to weigh in, up to 15 minutes. Being 15 minutes or more late results in automatic disqualification. Any participant caught trolling during tournament hours will be disqualified. Any participant who is drunk and disorderly or is involved in a fight during tournament hours will be disqualified. An exception will be made if the participant involved is only trying to stop or break up a fight. Lawter & Associates, PLLC has the right to refuse any entry form for any reason.

**Safety-**Safe motoring conduct must be observed at all times, including caution and safety on all morning take-offs. Each person must wear a Coast Guard-approved life preserver when the boat is on plane. Each boat will be required to have a working "kill switch" which must be attached to driver at all times when boat is on plane.

**Hourly Big Bass-**One (1) big bass will be weighed and released per hour per boat. These fish will count towards your total weight at the end of tournament. The deadline for the hourly big bass is at the top of each hour (i.e., 10:00, 11:00, etc.) ending at 1:00pm. The first weigh in will begin at 9:00am for the 10:00 am Big Bass.

**Polygraph-**If any person fails the polygraph test in this tournament they will automatically be disqualified. If any person refuses the polygraph test team will automatically be disqualified. **If any person is too intoxicated to take polygraph, or the polygraph service believes that the team who is selected to take polygraph is too intoxicated, that team will forfeit their team's prize money.**

Protest must be made in writing within 15 minutes of the last person to weigh-in.

**1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and Big Bass must be present on Sunday to claim their checks.**
